Our Solutions

One Call Customs Solution - powered by Kona

Our game-changing all-in-one cross-border data solution is a single API call that covers all areas of critical data required to move eCommerce across borders.

Kona improves data accurately and efficiently, allowing traffic to flow through customs, calculates duties and taxes (even without an HS code) and its compliance screening gives businesses the tools to demonstrate they have conducted due diligence.

Product Classification - powered by Zephyr

Hurricane's API takes a new approach to a realworld problem, enabling the efficient checking and completion of cross-border shipment preadvice submitted to authorities by retailers.

Our Product Classification module checks that the HS6 code and description are validated and, if not, will return a status code indicating where the issue is. In addition, it will provide suitable customs clearance information including a valid description, a most likely HS6 and 8- and 10-digit export and import codes. It is easy to integrate and blisteringly fast with return times of 100 milliseconds. It is also multilingual and multicurrency.

Duty and Tax Calculation, Prohibited & Restricted Goods Screening and Denied Party Screening - powered by Aura

Our Aura API can match products using a client's HS6 code and product description.

An API call through this module is extremely fast, with throughput tested at over 640 transactions a second, equating to 55 million a day.

One single API call can perform 3 key crossborder functions (duty & tax calculation, prohibited & restricted goods screening and denied parties screening) and present the data back in real-time, providing a seamless performance that won't affect the efficiency of your operating processes.
